Addendum No. (s) and Date (s)	Addendum No.1 – March 24, 2023
Project Description	The project consists of, but is not limited to, providing site protection, power washing, spot surface preparation and coating rehabilitation of interior and exterior coatings, and application of exterior high performance overcoat coatings. Standpipe No. 1 is 2.0 million gallon in capacity, constructed of welded steel plate, and is 61-feet in diameter and 92-feet in height to overflow. Standpipe No. 2 is 3.0 million gallon in capacity, constructed of welded steel plate and is 76-feet in diameter and 90.5-feet in height to overflow.
Special Requirements	The intent is to complete rehabilitation of both tanks in fall of 2023. The first tank is scheduled to be taken offline by the first week of September, potentially sooner. Once the first tank is back online, the second tank will be drained immediately, and work is expected to be completed by mid-November 2023. The Contractor shall supply all labor and materials and equipment necessary to complete the work shown on the Contract Drawings and hereafter contained in the Specifications.
