The water main replacement work is from the intersection of Oak Street to the intersection of Marion Street approximately 2,600 linear feet of new 12" ductile iron pipe. The remaining work area on Bacon Street includes replacing water services, two (2) new 10-inch ductile water main spot repairs and new 10 inch water main under a drain culvert pipe.
