Project Description	The project consists of but is not limited to installing approximately 2,400 LF of 8-inch water main on Chace Hill Road, 200 LF of 6-inch water main and 670 LF of 8-inch water main on Seven Bridges Road, 2,100 LF of 12-inch water main on Neck Road including a railroad crossing, 350 LF of 8-inch water main on Harvard Road between Neck Road and Seven Bridge Road, 2,050 LF of 8-inch water main and 1,300 LF of 6-inch main on Ponakin Road, and 1,700 LF of 8-inch water main on Schumacher Road. Water main pipe shall be ductile iron pipe, installed with hydrants, services, and appurtenances. New pipe to be laid while existing water main is active, temporary bypass not anticipated. The project will also consist of the replacement of existing culverts that the water main crosses on Chace Hill Road and Harvard Road if deemed necessary during construction, the relocation of one catch basin and the installation of one drain manhole.
